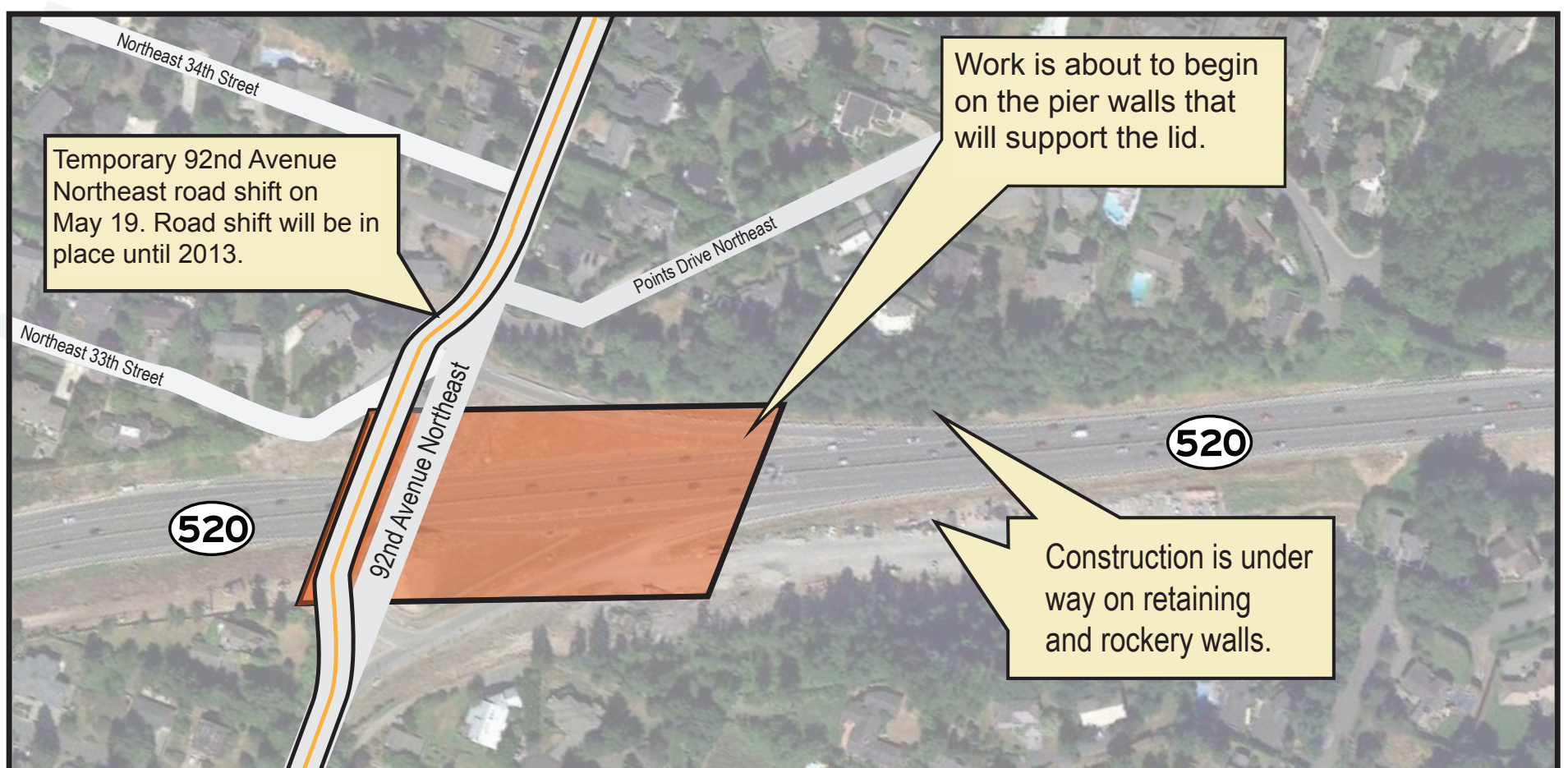


## NOTICE: Traffic shift at 92nd Avenue Northeast

On Saturday, May 19, 92nd Avenue Northeast traffic over SR 520 will be shifted onto a piece of the new lid so that crews can demolish the existing 92nd Avenue Northeast overpass. That demolition is currently scheduled for June 1-4 when SR 520 will again be closed between I-405 and Montlake Boulevard. Until the shift occurs, crews will be busy completing the earthwork, paving and striping necessary to safely move traffic from the existing roadway onto the lid.

This will be a temporary traffic change so that crews can remove the existing 92nd Avenue Northeast overpass and make room for construction of supporting walls that will hold up the lid deck to the east of 92nd Avenue. This shift will be in place until 2013 when traffic is shifted back into its final configuration over the lid.

This work is scheduled to occur mostly during daytime hours. However some nighttime work will be required, especially June 1-4 when the bridge is demolished. At that time, residents should expect to hear the sounds of concrete demolition, trucks, bulldozers, excavators, back-up alarms and light generators.



### Mark your calendars for the upcoming full closures of SR 520:

- Friday, June 1 - Monday, June 4 - crews will demolish the 92nd Avenue Northeast overcrossing and set more girders for the Evergreen Point Road lid.
- Friday, July 13\* - Monday, July 16\* - crews will demolish the 84th Avenue Northeast overcrossing.
- Friday, Aug. 10\* - Monday, Aug. 13\* - crews will install a new fish-friendly culvert and demolish a portion of the Bellevue Way Northeast overcrossing.

\* **Tentative:** Dates will be confirmed prior to each closure.

The Eastside Transit and HOV Project will complete and improve the 8.8-mile HOV system from Evergreen Point Road in Medina to the SR 202 interchange. The improved six-lane corridor will include two general-purpose lanes and one transit/HOV lane in each direction.

Key features include:

- An inside transit/HOV lane through the entire Eastside corridor.
- Cleaner, nicer median transit stops at Evergreen Point Road and 92nd Avenue Northeast that are ADA accessible.
- Wider, safer shoulders.
- Direct-access ramps to 108th Avenue Northeast for carpools and transit.
- A regional bicycle and pedestrian path.
